I refer to your fax of the 17 February 2003, concerning the 45 km/h speed restriction imposed on your hydraulically steered Franna AT15 mobile cranes.

Based on the information contained in your facsimile which certifies that the AT15 is identical in specifications to the AT 14 in all respects (except for the winch and load indicating system) and the fact that the AT14 will now be produced as the AT15.

In light of this information, as well as the previous approval to allow the AT14 to operate at the higher speed of 80 KPH the Roads and Traffic Authority (RTA) has no objection for the Franna AT-15 to operate up to a maximum speed of 80 km/h provided the following conditions are adhered to:

- Hydraulic steering warning decal to be modified to display maximum speed limit of 80 km/h.
- Where the sign posted speed limit is less than 80 km/h the sign posted speed limit is not to be exceeded.

With regard to any other Franna mobile crane models, the RTA will require individual evaluation for each vehicle model to properly assess all safety implications before amending their speed limit restrictions.
